A KEY FOCUS IS ECONOMIC SECURITY THOUGH DEVELOPMENT OF SMALL ECONOMIC ENTERPRISES. WE PROVIDE FUNDING FOR LOCALLY OWNED LENDING POOLS, TRAINING ON BUSINESS SKILLS, AND COACHING OF SMALL BUSINESSES. WE WORK WITH EXISTING LOCAL WOMEN'S ORGANIZATIONS, AND WE PARTNER WITH THEM ON STRENGTHENING THEIR LOCAL ORGANIZATIONS.
